Pursuant to Rule 15-204 NMRA, I understand that I am responsible for fees and costs associated with any investigations and hearings regarding my character and fitness to practice law and hereby authorize the New Mexico Board of Bar Examiners to assess and collect these costs and fees against me as incurred.
